SUMMARY ANNUAL REPORT

For Thomas Jefferson University Hospitals, Inc. Defined Contribution Pension Plan

This is a summary of the annual report for Thomas Jefferson University Hospitals, Inc. Defined Contribution Pension Plan, EIN 23-2829095, Plan No. 004, for period January 01, 2010 through December 31, 2010. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided by insurance and a trust fund. Plan expenses were \$2,637,295. These expenses included \$15 in administrative expenses, and \$2,637,280 in benefits paid to participants and beneficiaries. A total of 5,548 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$114,662,363 as of December 31, 2010, compared to \$83,743,395 as of January 01, 2010. During the plan year the plan experienced an increase in its net assets of \$30,918,968. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$33,556,263, including employer contributions of \$11,862,195, employee contributions of \$10,091,149, earnings from investments of \$11,380,855, and other income of \$222,064.

You have the right to receive a copy of the full annual report, or any part thereof, on request. The items listed below are included in that report:

- an accountant's report;
- financial information;
- information on payments to service providers;
- assets held for investment;
- fiduciary information, including non-exempt transactions between the plan and parties-in-interest (that is, persons who have certain relationships with the plan);
- insurance information, including sales commissions paid by insurance carriers;
- information regarding any common or collective trusts, pooled separate accounts, master trusts or 103-12 investment entities in which the plan participates;

The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
