**Summary Annual Report
For Thomas Jefferson University Retirement Plan for Faculty and Senior Administrative Staff**

This is a summary of the annual report for Thomas Jefferson University Retirement Plan for Faculty and Senior Administrative Staff, EIN 23-1352651, Plan No. 003, for period July 1, 2009 through June 30, 2010. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided insurance and through a trust fund. Plan expenses were \$14,807,457. These expenses included \$1,002 in administrative expenses, and \$14,806,455 in benefits paid to participants and beneficiaries. A total of 3,564 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$358,599,968 as of June 30, 2010 compared to \$331,472,481 as of July 1, 2009. During the plan year the plan experienced an increase in its net assets of \$27,127,487. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$41,934,944, including employer contributions of \$12,227,950, earnings from investments of \$27,384,870, and other income of \$2,322,124.

You have the right to receive a copy of the full annual report, or any part thereof, on request. The items listed below are included in that report:

1. an accountant's report;
2. financial information;
3. information on payments to service providers;
4. assets held for investment;
5. insurance information, including sales commissions paid by insurance carriers; and
6. information regarding any common or collective trusts, pooled separate accounts, master trusts or 103-12 investment entities in which the plan participates.
