

## Nursing Licensure Disclosure for Non-Pennsylvania Residents

An educational program that is designed to meet requirements for a specific professional license or certification required for employment in that occupation must meet certain elements of disclosure related to eligibility to seek licensure. The following information serves to inform prospective applicants and/or matriculated students whether the curricula in programs in nursing at the Jefferson College of Nursing:

- meet respective State Board of Nursing educational requirements for licensure or certification in a given state,
- do not meet respective State Board of Nursing educational requirements for licensure or certification in a given state, or
- whether a respective State Board of Nursing does not identify if the curricula in programs at Jefferson College of Nursing meet the State's educational requirements for licensure.

The nursing programs at Thomas Jefferson University, Jefferson College of Nursing are approved by the Pennsylvania State Board of Nursing and accredited by the Commission on Collegiate Nursing Education (CCNE). **For new licensure applications, Boards of Nursing typically require that an applicant for RN licensure be a graduate from an approved and accredited program of study. For advanced practice registered nurse (APRN) licensure, applicants must hold an active RN license and be a graduate of an accredited program of study. Eligibility for licensure requirements can vary from state to state.**
