2022-2023 APPLICANTS AND ENROLLED STUDENTS REPORT

APPLICANTS

Over the cycle of 2022 through 2023 Fall, **193 individuals** have initiated or submitted applications for graduate studies in the Community and Trauma Counseling (CTC) program at Thomas Jefferson University. The number of these applicants did not include track-up students who proceeded to the CTC program upon completion of their undergraduate studies at Thomas Jefferson University.

Of the 193 individuals, 48.7% identified as White, Black or African American (15.5%), Hispanic of any race (6.2%), Asian (4.7%), and two or more races (5.2%). In addition, 14.5% of the applicants identified as non-resident Alien. Furthermore, of the 193 applicants, 80.0% identified as female while 15.5% identified as male for sex when 3.1% of data was missing. For gender, 72.5% identified as female, 13% as male, 1% as other than listed, and .5% preferred not to answer. There was 9.8% of missing data.




Figure 1. Self-Identified Permanent City of Residence




Figure 2. Self-Identified Permanent State of Residence

The applicants varied in permanent city and region (i.e., state or jurisdiction of the United States) of residence by self-report. Specifically, the diverse cities (see Figure 1) and diverse regions (see Figure 2) were reported among the 193 applicants while 27.5% identified Philadelphia City as permanent city of residence, and 58.8% and 9.8% as Pennsylvania and New Jersey, respectively, as permanent region of residence.

Of the 193 applicants, **25.91% or 50 individuals** has been enrolled at the time the admissions and enrollment data were released. Furthermore, these individuals have been confirmed the acceptance and enrolled in the CTC program at the time this report was written. Additionally, 65.8% or 127 individuals have decided to withdraw their application at any time over the cycle of the 2022-2023 admissions. Moreover, 4.7% applicants have deferred their decision.

ENROLLED STUDENTS

Of the 50 enrolled students with an age range (21-55), 41.2% identified as White, Black or African American (17.6%), Hispanic of any race (11.8%), and two or more races (11.8%). Moreover, 82.4% of the 50 enrolled students identified as female while 11.8% reported as male in relation to sex given at birth. For gender, 70.6% reported as female while 9.8% reported as male when 11.8% of data was missing.

The enrolled students varied in permanent city and region (i.e., state or jurisdiction of the United States) of residence by self-report. Of the 50 enrolled students, 27.5% identified Philadelphia City as permanent city of residence, and 72.5%, 3.9%, and 9.8% as Pennsylvania, Delaware, and New Jersey respectively, as permanent region of residence.
