# Weapons, 131.01

# **PURPOSE**

The purpose of this policy is to ensure the safety and protection of all students, employees, patients, contractors, and visitors to Thomas Jefferson University and Jefferson Health (collectively referred to as "Jefferson") campuses.

## **DEFINITIONS**

Dangerous Weapons: Firearms, imitation firearms, explosives, knives, brass knuckles, tasers, devices capable of discharging a projectile, and any illegal weapon or any other item that can be used as an offensive weapon.

Defensive Weapons: Defensive sprays such as mace, OC spray, and pepper spray. Any questions about whether an item is covered by this policy should be directed to the Security Department for clarification. All persons will be held directly responsible for making sure beforehand that any potentially covered item possessed is not prohibited by this policy.

Jefferson property covered by this policy includes, without limitation, all Jefferson owned or leased buildings and surrounding areas such as sidewalks, walkways, driveways, plazas, and parking lots and garages under Jefferson's ownership or control. Jefferson vehicles are also covered by this policy at all times regardless of whether they are on Jefferson property at any time. This policy also prohibits weapons at any Jefferson sponsored function, such as parties or picnics.

### **POLICY**

Jefferson prohibits all persons who enter Jefferson property, as defined above, from possessing a

Dangerous Weapon regardless of whether the person is licensed to carry the weapon.

Employees, contractors, students, and guests (other than visitors to the ED) are permitted to have a Defensive Weapon in their possession while on Jefferson property. At no time should any person display or use a Defensive Weapon on Jefferson property unless immediately required for self-defense purposes. If an employee is involved in an incident involving the display or use of a defensive weapon, a Jefferson Security Director will confer with Human Resources following an investigation to render a decision regarding whether the display or use of a Defensive Weapon was required for self-defense purposes. If a student is involved in an incident involving the display or use of a defensive weapon, the matter will be handled in consultation with Jefferson Security, in accordance with the Community Standards policy.

This policy applies to all Jefferson students, employees, contractors, patients, contractors and visitors on Jefferson property, and customers and contractors on Jefferson property, regardless of whether they are licensed to carry a concealed weapon. The only exceptions to this policy will be on duty law enforcement personnel, uniformed law enforcement officers, or other persons who have been given written consent by Jefferson's VP of Public Safety to carry a weapon on the property. The VP of Public Safety or designee may provide an exception. Violators of this policy are subject to disciplinary action up to and including termination/expulsion.
