### Course Description

Allied health professionals are bound by both ethical principles and the law. It is the responsibility of therapists to know and understand these principles and to use them to guide their behaviors. This 2.5-hour lecture will cover key legal and ethical issues and considerations for medical professionals with a focus on Allied Health professionals such as physical therapy, occupational therapy, speech language pathologists. Topics will range from a general overview of the medical malpractice law in Pennsylvania and what to expect if the professional is either named in a lawsuit or a witness in a lawsuit and the various ethical and legal issues involved, to the legal and ethical issues related to the Anti-Kickback Statute, Stark, the False Claims Act, and the Apology Act. The course is appropriate for clinicians of all levels, including students.

**Target Audience:** Physical Therapists, Physical Therapist Assistants, Occupational Therapists, Occupational Therapists Assistants and Speech Language Pathologists.

**Course Learning Objectives:** At the conclusion of this learning activity the participants should be able to:

- Explain the Anti-kickback/Stark law and potential liability of allied health providers
