<u>Jefferson Global Radiology: Resident Travel Checklist</u>

Initial information that you should know prior to beginning:

You will be required to apply for scholarships and grants to help fund your travel unless you plan to pay for yourself. Airfare, housing, visas, vaccines, travel health insurance, and food are the responsibility of the resident. Save receipts related to travel regardless of funding mechanism. If you get an Office of International Affairs (OIA) scholarship or other travel grant, that money can help cover your non-department expenses.
