

Population Health Pharmacy focuses on:

- The impact of the distribution of health determinants on those receiving medication management services by pharmacists
- Strategies used to improve health outcomes associated with medication use
- 100% online coursework delivered in an asynchronous manner by experienced pharmacy and population health faculty
- Two, 7-week terms will be offered for the Fall, Spring, and Summer
- Students can begin the program in the Fall (September) or Spring (January) terms

Capstone Project

- The capstone project allows the learner to demonstrate the integration and application of programmatic content
 - Consists of a scholarly manuscript and presentation
 - Conducted under the guidance of a faculty advisor
 - Projects can be self-selected to ensure the topic is of interest or benefit to the learner and/or their institution
- Required only for the MS degree
